## O. ACTION ITEMS - BUSINESS

WHEREAS, the Elwood Union Free School District has incurred a series of unanticipated ordinary contingent expenses during the 2023-2024 budget year, which are necessary to effectuate the education of the students of the Elwood Union Free School District relating primarily to security and technology infrastructure; and WHEREAS, the District has available unassigned fund balance sufficient to fulfill its obligations to pay for these legally required expenditures; and WHEREAS, the District wishes to designate available unassigned fund balance to pay for these legally required expenditures;

NOW THEREFORE BE IT RESOLVED, that the Board of Education authorizes a

budget revision increasing the budget in the amount of \$300,000 to allow for the use of unassigned fund balance to pay for the unanticipated ordinary contingent expenses referenced herein; and

BE IT FURTHER RESOLVED, that upon the recommendation of the Interim Superintendent of Schools, the Board of Education authorizes the transfer of \$300,000 of the available unassigned fund balance to the (Object codes 1622 & 2630) item lines of the 2023-2024 Budget to allow for the payment of unanticipated ordinary contingent expenses, which the District is legally obligated to pay.

- 2. WHEREAS, the Board of Education previously established and funded an Insurance Reserve Fund pursuant to Section 6-n of the General Municipal Law; and WHEREAS, the Board of Education has determined that it requires the use of said money for the purposes outlined in Section 6-n of the General Municipal Law. NOW, THEREFORE, BE IT RESOLVED that upon the recommendation of the Interim Superintendent of Schools, the Board of Education hereby authorizes the transfer of \$250,000 from the Insurance Reserve Fund to the General Fund for the purpose of utilizing said money for the settlement of certain action commenced against the school district.
- 3. BE IT RESOLVED, that upon the recommendation of the Interim Superintendent of Schools, the Board President is hereby authorized to sign and execute the following change order for Bond Phase IV Building Improvements at Elwood-John H. Glenn High School:

  Change Order No. 2: for Gatz Sitework & Landscape Construction, Inc. related to the repavement of the entire existing track asphalt subsurface to provide adequate surface for installation of specified rubber track system which will require an increase to the contract by \$139,061.40.
- 4. BE IT RESOLVED, that upon the recommendation of the Interim Superintendent of Schools, the Board of Education hereby authorizes the Board of Education President to sign and execute an Agreement with Abilities, Inc. at the Viscardi Center, to provide services to students with disabilities, effective July 1, 2023 through June 30, 2024, and said Agreement will be incorporated by reference within the minutes of this meeting.
- 5. BE IT RESOLVED, that upon the recommendation of the Interim Superintendent of Schools, the Board of Education of the Elwood Union Free School District, having reviewed a Settlement Agreement in Executive Session, hereby approves such Settlement Agreement and authorizes the Board of Education President to execute such Settlement Agreement.
- 6. BE IT RESOLVED, that upon the recommendation of the Interim Superintendent of Schools, the Board of Education hereby declares the various technology related items (i.e. projectors, access points, monitors, chromebooks, desktops & printers) presented to the Board at this meeting, as surplus and obsolete as they are beyond repair or outdated and allow for their appropriate removal.

WHEREAS, by email dated October 25, 2023, the Complainant notified the Superintendent of Schools that she was requesting a review of her complaint by the Board of Education; and

WHEREAS, in accordance with regulation 1420-R, the Superintendent of Schools delivered a copy of her October 11, 2023 communication and the Committees' reports to the Board of Education for its consideration.

NOW, THEREFORE, upon reviewing the October 11, 2023 communication from the Superintendent of Schools to the Complainant and the Instructional Review Committee's determination dated October 10, 2023 and giving due consideration to the concerns and complaints raised in the challenge to the library books entitled Flamer, the Board of Education sustains the determination of the Instructional Review Committee that was communicated by the Superintendent of Schools to the Complainant and denies the Complainant's appeal.

Mrs. Mammolito moved and Dr. Siddiqui seconded a motion to approve Item P.1 as presented to the Board at this meeting.

Motion carried. Vote: 4-yes, 1-no (Weiss).

2. WHEREAS, the District received a complaint regarding the content of a library book entitled Flamer at the John Glenn High School and a library book entitled Melissa/George at the Elwood Middle School; and

WHEREAS, pursuant to Board Policy 1420 and its accompanying regulation, 1420-R, the Superintendent of Schools designated Instructional Review Committees to investigate and judge the challenged material; and

WHEREAS, by letter dated October 11, 2023, the Superintendent of Schools notified the Complainant that the Instructional Review Committees issued a determination dated October 10, 2023 which concluded that the concerns and complaints presented did not rise to the level of removal of the challenged books from the John Glenn High School library and Elwood Middle School library; and

WHEREAS, by email dated October 25, 2023, the Complainant notified the Superintendent of Schools that she was requesting a review of her complaint by the Board of Education; and

WHEREAS, in accordance with regulation 1420-R, the Superintendent of Schools delivered a copy of her October 11, 2023 communication and the Committees' reports to the Board of Education for its consideration.

NOW, THEREFORE, upon reviewing the October 11, 2023 communication from the Superintendent of Schools to the Complainant and the Instructional Review Committee's determination dated October 10, 2023 and giving due consideration to the concerns and complaints raised in the challenge to the library books entitled Melissa/George, the Board of Education sustains the determination of the Instructional Review Committee that was communicated by the Superintendent of Schools to the Complainant and denies the Complainant's appeal.

Mrs. Mammolito moved and Dr. Siddiqui seconded a motion to approve Item P.2 as presented to the Board at this meeting.

Motion carried. Vote: 5-yes, 0-no.

BE IT RESOLVED, that upon the recommendation of the Interim Superintendent of Schools, the Board of Education hereby approves the Committee and Subcommittee on Special Education's recommendations for meetings held on 9/22/23, 10/5/23, 10/6/23, 10/10/23, 10/13/23, 10/22/23, 10/23/23, 10/25/23 and 11/1/23 and the Committee on Preschool Special Education's recommendations for meetings held on 10/16/23, 10/17/23, 10/18/23 and 10/26/23 for students' classifications/placements and/or discontinuance of services.
