- D. <u>REPORT FROM THE SUPERINTENDENT OF SCHOOLS</u> Michael A. Maina Schools opened with enrollment up 100 students from last year. The enrollment increase trend is continuing. Harley 607, K 199, Grade 1 206, Grade 2 202. Boyd 619, Grade 3 214, Grade 4 218, Grade 5 187. EMS 603 Grade 6 207, Grade 7 217, Grade 8 179 Glenn 630 Grade 9 179, Grade 10 156, Grade 11 164, Grade 12 131 Total Enrollment is 2,459 youngsters. Last year's enrollment was 2,360. Will discuss the enrollment in greater detail at the October 10<sup>th</sup> Board Meeting.

The 2002/03 school tax rate and the library services tax rate have been established, pending any further modification by the Town of Huntington, at \$130.31 and \$6.38 per \$100 A.V. respectively.
