WHEREAS, the Board of Education of the Elwood Union Free School District advertised for the bid of Building Improvements (Bond Phase 3) at John Glenn High School, James H. Boyd Intermediate School and Harley Avenue Primary School and Building and Site Improvements (Bond Phase 2) at Elwood Middle School and Harley Avenue Primary School;

WHEREAS, the Elwood Union Free School District received bids for the Building Improvements (Bond Phase 3) at John Glenn High School, James H. Boyd Intermediate School and Harley Avenue Primary School and Building and Site Improvements (Bond Phase 2) at Elwood Middle School and Harley Avenue Primary School; on April 21, 2021; and

WHEREAS, the District's Architect and Administration have reviewed the bids submitted by the bidders in connection with the Building Improvements (Bond Phase 3) at John Glenn High School, James H. Boyd Intermediate School and Harley Avenue Primary School and Building and Site Improvements (Bond Phase 2) at Elwood Middle School and Harley Avenue Primary School; and

WHEREAS, based upon said review, Stalco Construction, Inc., is the lowest responsible bidder on Base Bid No. GC-1 (General Construction), Xtraire Air Conditioning & Heating Service is the lowest responsible bidder on Base Bid No. MC-1 (Mechanical), Ambrosio & Company, Inc., is the lowest responsible bidder on Base Bid No. PC-1 (Plumbing), and J.P. Daly & Sons, Inc., is the lowest responsible bidder for Base Bid No. EC-1 (Electrical) in accordance with General Municipal Law section 103; and,

NOW, THEREFORE, BE IT RESOLVED that the Board of Education hereby awards the contract for the Building Improvements (Bond Phase 3) at John Glenn High School, James H. Boyd IS and Harley Avenue Primary School and Building and Site Improvements (Bond Phase 2) at Elwood Middle School and Harley Avenue Primary School as presented to the Board at this meeting and in accordance with the bid specifications:

- Base Bid No. GC-1 to Stalco Construction, Inc.
- Base Bid No. MC-1 to Xtraire Air Conditioning & Heating Service
- Base Bid No. PC-1 to Ambrosio & Company, Inc.
- Base Bid No. EC-1 to J.P. Daly & Sons, Inc.

BE IT FURTHER RESOLVED that the Board of Education of the Elwood Union Free School District hereby authorizes the Board President to execute the necessary documents on behalf of the Board of Education; and,

BE IT FURTHER RESOLVED, that the Assistant Superintendent for Business is hereby authorized to approve change orders in the maximum amount of \$25,000 per change order for this project.

**3.** BE IT RESOLVED, that upon the recommendation of the Superintendent of Schools, the Board of Education hereby authorizes the Assistant Superintendent for Business to make all necessary budgetary transfers for the end-of-year book closings.
